Non Trucking Auto Liability

Non-Trucking Liability is primary auto liability insurance for Owner Operator, when they are on long term lease to a trucking company, whilst they are off dispatch. The Trucking Company provides Primary Auto Liability insurance whilst they are on dispatch.

Dispatch is defined as the moment that the owner operator has been summoned to haul a load or go and pick up a load until he has returned to his home.

If he decides, whilst he is on dispatch, to unhook his trailer and do some private driving, he is still Covered on the Trucking Company's policy.

A long term lease is defined as a lease that is 30 days or more. As soon as the lease is terminated there is no cover on the Non-Trucking Liability policy, i.e., No lease, No cover

Unladen liability

Unladen liability is whilst the Owner Operator is on a long term lease, but is not carrying cargo. The same terms apply over leasing arrangements.

Bobtail Liability

Is very similar to Unladen Liability, but is purely whilst the truck is not pulling a Trailer.
